We process the following personal data:

- IT data (e.g. your access permissions)
- Information required to execute a contract
- Billing data (e.g. bank details)
- Framework agreement data

3.) Will my personal data be disclosed to third parties?

5.) How long will my personal data be stored?

6.) What rights do I have with regard to my personal data?

- Right to the restriction of processing (Art. 18 GDPR)
- Right to data portability (Art. 20 GDPR)
- Right to withdraw consent (Art. 7.3 GDPR)
- Right to lodge a complaint with a supervisory authority (Art. 77 GDPR)

Right to object:

You may object to the processing of your personal data at any time. Once we have received your request, we will stop using this personal data for direct advertising or market research, and we will delete the data if it is not being used for other purposes.
